1. NO PURCHASE NECESSARY. A PURCHASE OR TRANSACTION WILL NOT INCREASE YOUR CHANCE OF WINNING.
2. ADMINISTRATION; WSF. This sweepstakes is being administered and sponsored by the Washington State Fair (WSF), 110 9th Ave SW, Puyallup, WA 98371.
3. ELIGIBILITY. In addition to the other requirements set forth in these rules, the contest is open only to legal residents who are at least 18 years of age and are currently residing in the following states: Alaska, California, Georgia, Idaho, Illinois, Missouri, Oklahoma, Oregon, Pennsylvania, Texas, Virginia and Washington. Void in Florida, New York, Rhode Island and where prohibited by law. Employees and independent contractors of the Western Washington Fair Association and its affiliates, as well as their immediate family members (spouse, parent, child, sibling and their respective spouses), regardless of where they reside, and those living in the same household of each, whether or not related, are not eligible. Additionally, WSF reserves the right to disqualify any person from participation in the sweepstakes where such participation would, in the sole opinion of WSF, compromise or give the appearance of compromising the integrity of the sweepstakes.
4. SUBMISSION PERIOD. Submission period is from 6:00:00 a.m. PST June, 8th, 2019, through 11:59:00 p.m. PST June 16th, 2019.
5. ODDS OF WINNING: The odds of winning depend on the total number of eligible entries received.
6. WINNER ANNOUNCEMENT. Two winners will be selected in a random drawing to be held on June 19th, 2019 from all eligible entries received. The winner will be notified via e-mail and/or telephone on June 19th, 2019.
7. HOW TO ENTER. Entrants must fill out the contest entry form that is provided at each location with their first name, last name, email address and phone number. Once form is filled out completely place in locked enter to win box. Limit one entry per person.
8. PRIZE. Two prize winners will each receive a prize package (one package per winner) that includes two 2019 Washington State Fair adult admission tickets, two concert tickets (to be determined), forty food bucks and one hotel night stay for two people provided by hotel. The prize packages are valid at the 2019 Washington State Fair, August 30 – September 22, 2019. Prize packages will be sent via FedEx to the winners. The total retail value of each prize package

is approximately \$300.00. There is no substitution, transfer or cash equivalent for prizes. Refunds and/or exchanges will not be given for previously purchased tickets.

All decisions by WSF regarding the prize, this sweepstakes, the finalists and the winner are final, binding and conclusive on all matters. WSF, and any other partner or affiliate shall not be liable for late, lost, misdirected or unsuccessful efforts to notify the winner. Potential winner will be required to return an Affidavit of Eligibility, Release of Liability and, where not prohibited by law, a Publicity Release within seven (7) days of attempted delivery of same. Non-compliance With-in this time period or return of any prize notification as undeliverable will result in disqualification without further notice and an alternate winner will be chosen.
