DEPARTMENTAL EXHIBITORS RULES AND REGULATIONS

The general supervision of the entire Puyallup Fair, including all exhibits, entertainment and concessions, has been vested in the manager of the Association by the Western Washington Fair board of directors.

1. The Association will have officers on the grounds and will use every reasonable precaution in its power for the preservation and protection of persons, articles on exhibition, livestock and property; but will not be responsible for loss or damage by theft, fire or otherwise.

TRADEMARKS AND COPYRIGHTS

2. Certain words, slogans and graphic symbols have been established to represent the Puyallup Fair, and are the exclusive property of the Western Washington Fair Association. "The Puyallup Fair" is a trade name registered with Washington's Secretary of State. Artwork, slogans, music and other communications created to promote or represent the Association or its annual fairs are likewise protected by law. This includes the phrase "Do the Puyallup" and the music and lyrics of the song, "Do the Puyallup," the wordmark combining "THE PUYALLUP FAIR" with or without cow heads and other temporary slogans such as "Epic Fun," "I Love This Fair" or "Come Together".

The valuable trade names and protected slogans and symbols may not be used without the express written consent of the Fair. In general, permission is granted under license, i.e., for consideration, or by permission under special circumstances. Submit requests to the marketing manager, along with complete information on frequency and distribution, including examples or written description of the proposed use.

3. EXHIBITS MUST BE IN PLACE AT 8:00 A.M. THE FIRST DAY OF THE FAIR. CHECK EACH DEPARTMENT FOR POSSIBLE EXCEPTIONS.
4. The Western Washington Fair Association assumes no responsibility for loss or damage to entries. Every reasonable precaution will be used to protect items on display.

WHEN ADDRESSING CORRESPONDENCE TO THE FAIR, PLEASE NOTE DEPARTMENT TO WHICH IT BELONGS ON THE FACE OF THE ENVELOPE.

Read the special rules and other information printed in connection with the classification and prize list in each department. Note the time set for the closing of entries.

6. Every animal or article must be entered in the name of the owner, maker or grower.

ANYONE TRYING TO DECEIVE THE COMMITTEE WITH REGARD TO OWNERSHIP OF EXHIBIT, OR WHO SHALL PURCHASE OR BORROW THEM AND EXHIBIT THEM AS OF HIS OR HER OWN MANUFACTURE OR PRODUCTION, SHALL FORFEIT ALL CLAIMS AS AN EXHIBITOR.

7. No "FOR SALE" cards will be allowed on exhibits, in the buildings, or on the grounds.
8. Fair management reserves the right to cancel any class without prior notice for reasons deemed advisable by Fair legal counsel and/or Fair veterinarian.

ARRIVAL TIME OF EXHIBITS

9. The Puyallup Fair will be open for the receiving of articles according to the specified rules governing individual departments.

PREMIUMS AND AWARDS

10. First premiums shall be designated by blue ribbons, second premiums by red ribbons, third premiums by white ribbons, fourth premiums by pink ribbons, and fifth premiums by yellow ribbons.
11. No animal or article shall be allowed to compete for more than one open class premium, nor shall it be entered in more than one class, except as one of a herd, pair or pen, fur or wool, get of sire or dam, or in sweepstakes or championship classes. However, 4-H and FFA exhibitors may also show their registered livestock in open classes provided their entries are received by the closing date for entries in the open class, and providing there is no conflict in judging schedule with the junior show.
12. No animal or article shall be removed from the Fair before the close of the Fair except by special permission from the manager. Any animal or article taken away before the close of the Fair, without the permission of the manager, shall forfeit all premiums. **LIVESTOCK EXHIBITORS: SEE RULES IN REGARD TO SPLIT SHOWS UNDER SPECIFIC DEPARTMENTS.**
13. Unless otherwise stated by a specific department, in cases where exhibits are tied for prizes, awards shall be determined as follows:
 - A. If the premium is a trophy, medal or any other award except a cash prize, the exhibitors entering these exhibits shall draw lots, the winner being awarded the premium.
 - B. If the premium is a cash prize, the money shall be divided equally among the exhibitors concerned. The next lower cash premium, if any, offered in the class shall be added to the premium for which the entries are tied and then the division shall be made equally.
14. Cash prizes shall be paid to winners only in classes included in the judge's list.
15. The judges shall report only the animals or articles entitled to premiums in the judge's list, though they may commend others they deem

worthy. The superintendent may deny entry to any animal or exhibit he deems unworthy of public display.

16. No animal or article deemed unworthy shall be awarded a premium. No premiums shall be withheld merely because there is no competition. Decision of the judge shall be final.
17. No person shall be allowed to see the judging books until after the awards have been made and entered.

PENALTIES AND PROTESTS

18. The manager will appoint a superintendent and one or more judges for each division when deemed necessary. No person can act as a judge in any division or class in which there is any direct or indirect interest in the result as owner or agent; and when awards have been made in violation of this rule the manager reserves the right to appoint a new judge and to compel another examination.
19. Any person interfering with the judge during the adjudication of awards will forfeit the right of premiums. All officers or judges are required, and exhibitors are requested, to report any violation of this rule to the manager of the Puyallup Fair.
20. All protests must be made in writing, and must be accompanied by a deposit of \$25.00, which will be forfeited if protest is not sustained. Such protest must state plainly the cause of the complaint or appeal, and must be filed with the manager within 24 hours after the cause of protest.
21. **NO PERSON SHALL BE ALLOWED TO SELL OR GIVE AWAY ARTICLES ON THE GROUNDS, EITHER DURING THE FAIR OR AT ANY TIME BEFORE THE COMMENCEMENT OF THE SAME, UNTIL THE LICENSE FOR THE PRIVILEGE SHALL HAVE BEEN PAID AND RECEIPT THEREFORE ISSUED. THIS INCLUDES BALLOONS OR OTHER NOVELTIES FOR WHICH THE FAIR CONTRACTS THE SALE PRIVILEGE.**

ELECTRICAL USAGE NOTICE

Electrical appliances which draw more than 200 watts and which are used for the personal convenience of exhibitors (kettles, coffee pots, space heaters, air conditioners, hot plates, etc.) are not allowed without permission. A costly power failure can result from overloading circuits.

OPEN CLASS VETERINARIAN INFORMATION: WITHIN STATE OF WASHINGTON

The following are the minimum animal health requirements for the Puyallup Fair, including cattle, goats, sheep, llamas, horses, swine, pigeons, poultry, rabbits and cavy's originating within the state of Washington.

1. Individual Certificate of Veterinary Inspections on Washington animals is not required for entry into the Fair.
2. No animal from a quarantined area or premise may be permitted to enter the Fair or show.
3. OUT-OF-STATE ANIMAL ENTRIES MUST COMPLY WITH STATE OF WASHINGTON IMPORT REGULATIONS. NO EXEMPTIONS UNLESS EXEMPTED BY RULE.
4. Fair veterinarians will inspect all classes of livestock and poultry (including, but not limited to cattle, swine, horses, pet animals, rabbits, fur-bearing animals, pigeons, ducks, geese, turkeys, etc.) before they are exhibited to determine that the livestock and poultry show no clinical indications of contagious, infectious diseases and ectoparasites.
5. Fair veterinarians will reject any animal with infectious or contagious diseases or ectoparasites. Exhibitors should be made aware that ringworm, warts, pinkeye, strangles, contagious ecthyma, scabies, lice, mites, ticks and fleas fall into these categories.
6. Animals exhibiting disease symptoms during the course of the Fair will be removed from the exhibit areas, and either be sent home or kept in a quarantined area.
7. It is strongly recommended, but not required, that cattle be vaccinated in the current show year against respiratory diseases.
8. The Fair veterinarian's professional decision as to the health status of an animal will be final and will be upheld by the Fair Board.
9. Animals and birds not intended for exhibition will be denied entry to the grounds. Please leave your pet at home for its own protection, with the exception of guide/service dogs. They should be properly protected against infectious and communicable diseases as indicated for exhibit animals.
10. The Puyallup Fair requires all goats and sheep to be tagged or tattooed with Scrapie Identification.

Please remember that E.coli 0157:H7 infection can be transmitted by contact with animals. Youngsters, seniors and immune impaired persons are particularly susceptible. Hand washing facilities should be available wherever human-animal or animal waste contact is possible, and signage directing the public to those facilities is appropriate.

OPEN CLASS VETERINARIAN INFORMATION: OUT OF STATE

Exhibitors of animals and birds originating outside of Washington must comply with state rules and regulations in addition to the requirements of the Puyallup Fair.

Entry permits are required for all out-of-state cattle. A blanket permit to each fair will be issued upon request by calling (360) 902-1878. The blanket permit number for the 2008 Puyallup Fair is 91-Z869

for out-of-state exhibitors. Their veterinarians need not call if they use this permit number on health certificates for this fair only.

Permits for special livestock sales may be obtained by calling the Livestock Identification Program at (360) 725-5505.

All out-of-state animals going to fairs must have a Certificate of Veterinary Inspection except for Idaho

and Oregon dogs, horses, sheep, goats, alpacas and llamas traveling to Washington with their owners in personal vehicles for roundtrip visits of not more than 96 hours. It requires that the Fair management provides veterinary inspection on arrival, and rejects any unhealthy animal. This exemption does not apply during emergency disease conditions declared by the State Veterinarian, or extend to any required testing.

OUT-OF-STATE CATTLE

All cattle are required to have a Certificate of Veterinary Inspection (health certificate), an import permit, which may be the blanket permit for the Fair, 91-Z869, and brucellosis vaccination for female cattle

Any dairy bulls over six months of age and any Dairy females over 20 months require a negative Brucellosis test within 30 days of shipment.

Any dairy bulls and heifers over six months of age require a negative Tuberculosis test within 60 days of shipment.

Any breed cattle over six months of age from the states of Michigan, Minnesota and New Mexico require a negative Tuberculosis test within 60 days of shipment

All cattle are required to have an ownership inspection (brand) prior to leaving the state of origin.

OUT-OF-STATE SHEEP AND GOATS

All sheep and goats are required to have a Certificate of Veterinary Inspection and all rams require an entry permit number. All sheep and goats must have official scrapie identification. Sheep and goats from Oregon and Idaho on a round trip of 96 hours or less are exempt from the requirement of a Certificate of Veterinary Inspection, provided the Fair management furnishes veterinary inspection on arrival and rejects any unhealthy animals. For stays longer than 96 hours, they must meet the Washington state import requirements.

If lactating goats are entering, their milk must be discarded during any stay in Washington, unless they have been tested for Brucellosis and Tuberculosis.

OUT-OF-STATE ALPACAS LLAMAS

Llamas and alpacas are required to have a Certificate of Veterinary Inspection. The exception includes those from Idaho and Oregon on a round trip of not more than 96 hours, provided the Fair management furnishes veterinary inspection on arrival and rejects any unhealthy animals.

OUT-OF-STATE POULTRY & PIGEONS

All poultry entering Washington State for exhibition purposes must be accompanied by a Certificate of Veterinary Inspection (health certificate) within 30 days of shipment.

All poultry entering Washington state for exhibition purposes must originate from a NPIP participant flock or be tested negative for pullorum-thyphoid, Salmonella enteritidis and avian influenza within 30 days of shipment.

OUT-OF-STATE HORSES

All horses are required to have a Certificate of Veterinary Inspection, and horses over six months of age are required to have evidence of a negative test for (EIA) equine infectious anemia within six (6) months of entry.

Horses from Oregon and Idaho on a round trip of 96 hours or less are exempt from the requirement of a Certificate of Veterinary Inspection and EIA testing, provided the Fair management furnishes veterinary inspection on arrival and rejects any unhealthy animals

All horses are required to have an ownership inspection (brand) prior to leaving the state of origin.

OUT-OF-STATE SWINE

All swine are required to have a Certificate of Veterinary Inspection and an import permit number, which may be the blanket permit number issued to that fair.

All swine six months and over must be negative to a Brucellosis test within 30 days prior to entry into Washington, except swine originating from a validated Brucellosis-free herd or state.

VEHICLE UNLOADING PROCEDURES

The Puyallup Fair is continually striving to make setup of merchandise and animal exhibits safer and more efficient. We are asking for your full cooperation in this safety program. **If you do not need to drive onto the grounds, please park in a Fair parking lot and hand truck or walk in.** When you have to drive in and unload, do so as quickly as possible and exit.

Security Check

Each vehicle entering the grounds will be subject to search prior to entering the grounds. Please enter designated Security Checkpoint Staging Area located at the Service Gate area. Expect delays.

Service Gate

Enter to receive vehicle permit to unload on grounds. You will be allowed one hour to unload and exit the grounds. Your pass will be date/time stamped. If you absolutely cannot complete your unloading in one hour, you must get the pass validated by a department superintendent or an administrative person.

Traffic Pattern

Follow the traffic patterns as established. Surrender the vehicle permit at the time you exit the grounds.

Fine

If you take longer than one hour and do not have validation for an extension, there is a parking fine of \$10.00 per hour.

During Fair Time

Concessionaires and sponsors with vehicles will be allowed through the Service Gate between 6:00 am and 8:30 am with a Service Road Vehicle Permit. You will receive your gate permit from the attendant at the gate. **NO** vehicles are allowed through the gate after 8:30 am. All vehicles must be removed from the grounds by 9:00 am. Vehicles left unattended and without a permit for parking past the allotted time will either receive a warning and be asked to remove the vehicle from the grounds or be towed away at the owner's expense. Do not park in front of doorways or in vehicle traffic lanes. Your vehicle may be towed away. **HANG VEHICLE PERMIT ON THE REAR VIEW MIRROR SO YOU CAN BE FOUND IN AN EMERGENCY. Include the building where you can be located and your cell phone number.** Please unload quickly and remove your vehicle from the grounds. **NO KEYS ARE TO BE LEFT IN MOTORIZED VEHICLES ON DISPLAY.**

DAIRY GOAT SHOW RULES

1. Entry forms must be postmarked on or before midnight August 15, 2008. Please keep a copy for your records.
2. Entry fee will be \$5.00 per head. **Entry fee is due with entry form.** NOTE: Herd name **MUST** be listed on entry of each animal (may be abbreviated).
3. The Puyallup Fair will provide bedding and hay. Straw and hay **MAY NOT** be used to re-bed trucks and trailers. Please do not abuse the privilege of having the Puyallup Fair provide free hay and straw.
4. Goats must be delivered between 6 am and 10 am on Tuesday, September 9, 2008 to assigned pens. If there are any questions, check with the superintendent.
5. Animals must be removed between 6 pm and 8 pm on Thursday, Sept. 11, 2008.
6. All animals will be inspected by the Fair veterinarian before penning. The assistant superintendent will check in with Fair vet. Check with her for sign-in. No animals with any type of infectious disease will be allowed. The inspection committee and Fair veterinarian have the final say. Certificate of vet check must be turned in to be issued pen assignment and a livestock parking pass.
The Puyallup Fair requires that all goats be tagged or tattooed with Scrapie Identification. It is mandatory that animals having partial tattoos shall have accompanying identification papers to present to the veterinarian upon check-in.
7. **Exhibitor description: All animals registered and owned are under the same ADGA number.**
8. Papers **MUST** be checked by clerks by 2 pm on Tuesday, Sept. 9, 2008.
9. Certificates of registration in the American Dairy Goat Association, the American Goat Society, or the Canadian Goat Society are required on all dairy goats shown. Proof of ownership shall be the name on the registration or recordation certificate, or on the stamped duplicate application. Persons showing animals whose registration/recordation certificates have signed transfers that have not been processed by the

A.D.G.A. office must show those animals as agent for the owner shown on A.D.G.A. records.

10. Exhibitors need to remember that, due to no milk out, unethical practices that detract from the show ring will be discriminated against by the judge when placing animals.
11. Unlimited entries per class may be shown by an exhibitor. However, premiums will only be paid to the **Top Two**. No cross entry in Dam and Daughter or Breeder's Trio allowed. Group entries must be listed on entry form. All animals shown in groups must be entered and shown as individuals.
12. All dairy goat handlers will wear whites in the show ring. No shorts may be worn.
13. Handlers are required to wear the correct ring number card for each class entered in the show ring. Ring number cards will be worn on the left arm.
14. As soon as possible upon arrival, please check in your registration papers to the SHOW SECRETARY so the office can get the Judge's List completed before show time. Gate and Livestock parking passes will be handed out at that time. Each exhibitor must check in their own papers. **Substitutions must** be within the same breed and class, and must be made before the day of show. **No class changes after final check-in will be allowed.** An animal will no longer be allowed to enter the show ring if it is not listed on the class sheet when entering the ring. No tattooing will be allowed after unloading. All tattoos must be legible (clearly readable) or animal will be disqualified by inspection committee. **Spot checks** may be made at random in the ring to verify tattoos and ownership.
Check your packet! All corrections must be finalized by 4 pm before exhibitors meeting. No corrections in the ring.
15. NO ANIMALS OTHER THAN ANIMALS TO BE SHOWN WILL BE ALLOWED; NO NURSING DOES, NO BUCKS, NO NEWBORN KIDS UNLESS BORN DURING TRANSPORT.
16. 4-H dormitories on the Puyallup Fair will be available for use by 4-H State Fair/State FFA Exposition exhibitors and their chaperones ONLY. Open class exhibitors should make arrangements for accommodations off of the Fair facility.

17. Violations of show rules will be implemented in the form of forfeiture of future showing at the Puyallup Fair. This will also apply to unbecoming behavior as an exhibitor.
18. It is required that all exhibitors have some form of herd identification display, plus exhibitor's name. NOTE: Only 2008 winning Puyallup Fair ribbons, rosettes and awards are to be displayed.
19. **NOTE:** Electrical appliances which draw more than 200 watts and are used for the personal convenience of exhibitors (kettles, coffee pots, space heaters, air conditioners, hot plates, etc.) are not allowed without permission. A costly power failure can result from overloading circuits.
20. **Animals may not be walked on or off the Fair facility** because of serious environmental concerns directly related to animal waste. Any animal (except horses) that cannot be transported in a solid bottom carrier must be removed in a truck, trailer or similar conveyance.
21. **Eating in the Barns vs. E.coli 0157:H7 – Exhibitor Cooperation Needed.**

Again this year our barns will not only have signage reminding Fair guests to "Wash your hands upon leaving any livestock area", but also "Please refrain from eating in livestock areas".

The state health department has asked the Fair to request that our livestock exhibitors set an example for Fair guests and refrain from eating in public areas in the barns. In order to accommodate the health department's request, as well as address our exhibitor's needs, we have set aside a good-sized area, screened from public view, in the south end of the Dairy Barn for exhibitors to eat.

PERFORMANCE AWARD

In order to emphasize the importance of a good balance of conformation and production in the American dairy goat, the Puyallup Fair is offering a production bonus. The award will be based on current DHIA/DGHIA records of no more than 305 days, nor less than 100 days, using % of herd M.E. (percent of herd mature equivalent) herd average (H.A.). The bonus will be paid on premiums earned in animals' individual classes.

100% OF H.A. - 109% OF H.A.	5% BONUS
110% OF H.A. - 119% OF H.A.	10% BONUS
120% OF H.A. AND ABOVE	15% BONUS

The ORIGINAL ILR (Individual Lifetime Record) for each participating animal must be turned in to the show secretary when registration papers are checked upon arrival.

DAIRY GOAT HERD DISPLAY

To present an attractive display, as well as to educate the public and promote the dairy goat industry, premiums will be awarded to exhibitors. Only 2008 Puyallup Fair ribbons, rosettes and awards are to be displayed. Displays will be judged on the following criteria:

- General Appearance: appeal, neatness, and total picture presented.
- Creativity: use of color, material, and ingenuity of presentation.
- Educational: display should tell a story about the exhibitor's breed or breeds, farm, and commodity.
- Exhibitor: cooperation with other exhibitors and Fair officials, and communication with the public.

Suggestions:

- Have an attractive herd sign and animal identification.
- Equipment and tack boxes painted and in good repair.
- Pictures and posters that promote the goat industry.

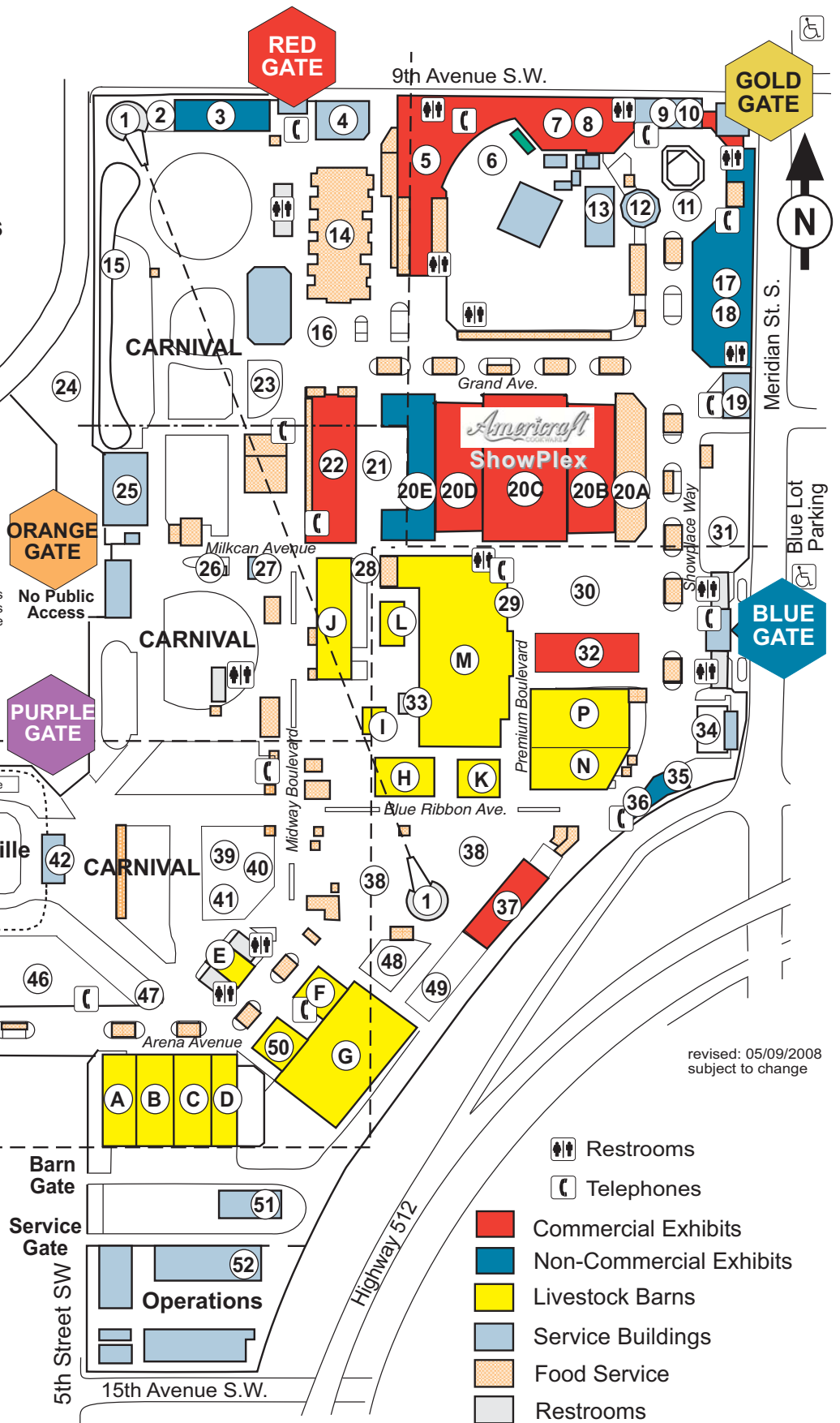
